The Policy should also be read in conjunction with other school policies including but not limited to the MGS Behaviour Policy.

The school will record attendance accurately in the register and share the required information with the DfE and local authority as required by the statutory guidance.

Miss Johnson, Deputy Headteacher is the School's Senior Attendance Champion. The Senior Attendance Champion is expected to set a clear vision for improving and maintaining good attendance, establish and maintain effective systems for tackling absence and make sure they are followed by all staff and have a strong grasp of absence data to focus the collective efforts of the school.

Section A – School Attendance

1. Statement of Intent

Maidstone Grammar School is committed to the continuous raising of achievement of all our students.

Good attendance and punctuality is essential for students to be successful and to get the most out of their school experience, including their attainment, wellbeing, and wider life chances. Poor attendance and punctuality undermine a student's education, adversely affect progress and can put a student at risk from a safeguarding point of view.

Improving attendance is everyone's business - we undertake to work in partnership with parents to support good attendance and punctuality and resolve attendance problems because every lesson counts. Where appropriate we will also engage support from external agencies to help us.

As a school our expectation is that students will achieve attendance at 95% or above and excellent punctuality.

All schools are required by law to have an admission register and an attendance register which must be kept electronically. All schools are also required to share their daily attendance data with the DfE, regardless of the age of the student. Information on whole school, group and individual attendance data / concerns / any other relevant issues etc will also be discussed with the SLO (School Liaison Officer) who oversees attendance for the local authority when appropriate – this is part of expected good practice for maintained schools.

2.The DfE Attendance Guidance (2024, section 14) outlines school's responsibilities with regards to attendance as below:

Expect

Aspire to high standards of attendance from all pupils and parents and build a culture where all can, and want to, be in school and ready to learn by prioritising attendance improvement across the school.

Monitor

Rigorously use attendance data to identify patterns of poor attendance (at individual and cohort level) as soon as possible so all parties can work together to resolve them before they become entrenched.

Listen and understand

When a pattern is spotted, discuss with pupils and parents to listen to and understand barriers to attendance and agree how all partners can work together to resolve them.

Facilitate support

Remove barriers in school and help pupils and parents to access the support they need to overcome the barriers outside of school. This might include an early help or whole family plan where absence is a symptom of wider issues.

Formalise support

Where absence persists and voluntary support is not working or not being engaged with, partners should work together to explain the consequences clearly and ensure support is also in place to enable families to respond. Depending on the circumstances this may include formalising support through an attendance contract or education supervision order.

Enforce

Where all other avenues have been exhausted and support is not working or not being engaged with, enforce attendance through statutory intervention: a penalty notice in line with the National Framework or prosecution to protect the pupil's right to an education.

5. The Role of the Student

It is the responsibility of the student to ensure they arrive in school on time and are present every day.

All students in Year 7-13 are required to arrive on time at their form room for statutory morning registration (8.40am) and statutory afternoon registration (1.55pm) Monday, Wednesday, Thursday and Friday. On Tuesdays, students must arrive punctually for the start of period 1 lesson, free or Private Study (8.40).

Other than Tuesday when students are registered at the start of period 1 and 5, registers are open from 8.40 – 8.45am at morning registration and 1.55-2pm at afternoon registration.

All students must attend all timetabled lessons (and study periods in the Sixth Form); lesson by lesson electronic registration will be taken for all classes.

Students may occasionally be unwell or late to school, but should take all reasonable steps to avoid this and not behave in a manner that increases the frequency of non attendance or lateness.

Any student in Year 7-13 who arrives late to school after morning registration must sign in at the Attendance Office immediately on arrival (located in the Student Services Centre in the corridor opposite the library). Students arriving up until 9am will be marked in as late (L). Students arriving late after 9am without an agreed reason will be marked as an unauthorised late (U). See 6th Form Section for further details on Year 12- Year 13 procedures.

In the afternoon (other than Tuesday), students arriving between 2pm and 2.15pm will be marked late (L).

Students who have lateness without an agreed reason will be required to make up the time through the school's sanction system.

All students in Year 7-11 are required to remain on site throughout the whole school day unless permission has been granted by the school, in which case they must sign out at the Attendance Office or front Reception before leaving the site.

In the Sixth Form, students will be permitted to leave the site during free periods once permission has been granted by SLT (which will usually be from after Christmas in Year 12).

Year 13 students are permitted to leave the site during free periods, unless otherwise instructed by SLT.

SLT reserves the right to remove off site privileges at any time for Sixth Form students including for academic underperformance and / or conduct concerns or in relation to attendance / punctuality concerns. **See Section B –Attendance in the Sixth Form for further details.**

All Sixth Form students must wear their lanyard with photo ID at all times when on site so that they can be identified as members of the school community. They must always present the Lanyard at the electronic reader when signing in or out during the school day for safeguarding reasons.

6. The Role of the Parent / Carer

The law entitles every child of compulsory school age to an efficient, full-time education suitable to their age, aptitude, and any special educational need they may have.

It is the legal responsibility of every parent to make sure their child receives that education either by attendance at a school or by education otherwise than at a school.

A person begins to be of compulsory school age —

- (a) when he attains the age of five, if he attains that age on a prescribed day, and
- (b) otherwise at the beginning of the prescribed day next following his attaining that age.

Prescribed days are 31 August, 31 December and 31 March

A person ceases to be of compulsory school age at the end of the day which is the school leaving date for any calendar year (the last Friday in June) —

- (a) if he attains the age of 16 after that day but before the beginning of the school year next following,
- (b) if he attains that age on that day, or
- (c) (unless paragraph (a) applies) if that day is the school leaving date next following his attaining that age.

Where parents decide to have their child registered at school, they have an additional legal duty to ensure their child attends that school regularly. This means their child must attend every day that the school is open, except in a small number of allowable circumstances such as being too ill to attend or being given permission for an absence in advance from the school. Failure to do this could result in the school making a referral for a Penalty Notice and fine for unauthorised absence.

Parents are also expected to support the school in ensuring their child's good punctuality.

In all cases where there are punctuality or attendance concerns we will try to work with parents as far as reasonably possible and we ask for and hope for their support. However, in situations where parents are not in agreement with sanctions applied, students are nonetheless required to complete the sanction set in accordance with the school's Behaviour Policy. Failure to do so will lead to escalation of the sanction and could potentially result in suspension for non compliance.

7. Punctuality

Good punctuality is very important. The school day starts at 8.40am sharp. All students are expected to arrive at their form room **from 8.35am** and prior to 8.40am for **morning registration which takes place from 8.40am to 8:45am**. (Except Tuesday's when statutory register is taken in Period 1 lesson). Students arriving after the register is taken by the tutor will be marked in as Late (L code) with the minutes late.

Students arriving after 8.45am must report to the Attendance Office to sign in and give the reason for their lateness.

Attendance staff oversee sanctions applied for lateness to statutory am/pm registrations. Where there is no justified reason agreed by the school, students are required to make up time missed through the detention system. In addition, detentions will be issued for persistent lateness (e.g three or more lates in a two week period) This is monitored on a two week cycle by Attendance. **See Section B for Sixth Form arrangements.**

All students must attend **afternoon registration from 1.55pm-2pm*** and stay for form time. Students arriving between 2.00 and 2.15 will be marked as late (L) by their tutor with the minutes late. (Except Tuesdays when statutory register is P5 for Year 7-11 and P4 or P5 for Year 13 (and Year 12 from Term 3).

Students are also required to be punctual to lessons and private study periods (6th form). Students in Year 7-13 arriving after the late pips will have their Punctuality / Attendance (P/A) card signed unless the school or teacher agrees there is a genuine and justifiable reason to account for this. Sanctions are applied for every 5 signatures or marks- full details given in the School Behaviour Policy. Justifiable reasons for lateness could include (for example only) a student arriving after a music lesson, coming from the medical room or following a meeting with a staff member. Staff will use their professional judgement when recording a justifiable lateness.

The Deputy Head (Inspire to Belong – students) and Headteacher will have the final say in determining whether a late is justified and agreed by the school, either for lessons or statutory registrations.

* Please note that the timings for afternoon registration are adjusted in Term 5 and 6 due to public examinations.

Monitoring

The school carries out regular monitoring of punctuality and attendance, including through its Cause for Concern meetings six times per year. Where persistent late concerns are identified the school will use a further range of strategies to address these including attendance/punctuality reporting to SLT at 8.30 each morning, communications with home and further escalating sanctions or other interventions where required. Please refer to the School's Behavior Policy and escalation procedures. Significant concerns in relation to unjustified poor punctuality / attendance will be dealt with at Level 3 or Level 4 or the escalation process on a case by case basis. In addition, there are fortnightly monitoring meetings in relation to 6th form punctuality and attendance. **Please see section B for Sixth Form Arrangements.**

Persistent lateness after the morning register has closed (U Code) could provide grounds for prosecution or a Penalty Notice (Years 7-11).

8. Absence from School

The 2 reasons a student can miss school are:

- The student is too ill to go to school
- the school has authorised the student to be absent.

The Attendance Office will text or email home on a daily basis for those pupils who are absent but whose parents /carers have not made contact with the school. Further contact will be made by the Attendance Office or other pastoral staff where concerns persist.

Absence (leave) during term time can only be approved in “exceptional circumstances”.

Parents cannot authorise absence – only the school.

In relation to one day leave of absence requests which are declined, parents can appeal to the Deputy Head (pastoral).

In relation to leave of absence requests for exceptional circumstances of more than one day which are declined, parents can appeal to the Headteacher.

In all cases, the Headteacher will have the final decision.

9. Authorised Absence due to illness

Most cases of absence due to illness are short term. For illness (and any other absence that has not previously been agreed by the school), parents must inform the school at the earliest opportunity as described below:

It is the responsibility of the parent to contact the school on the first day their child is absent AND on each successive day before 9am for safeguarding reasons. To do this parents should EITHER:

- **Telephone the MGS Absence Line on: 01622 623922**

Out of hours, parents will hear a recorded message inviting them to leave the following information:

- Child's Name
- Form Group
- Reason for Absence
- Expected Date of Return (if known); if unknown, please communicate daily until your child returns to school.

Information about the reason for each absence is always required, either in writing, by email or via a telephone message to the MGS Absence Line. Parents should explain the nature of illness, not just say ‘illness’ or ‘unwell’ or a signed appointment card or prescription/medicine label can be provided where medical attention has been sought.

9a Pupils absent from school due to mental or physical ill health or their Special Educational Needs and / or Disabilities.

MGS recognises that some students face additional obstacles / barriers to attending school. Where this is evidenced and the school is in agreement, pastoral staff will use their best endeavours to work with the students and parents/carers making reasonable adjustments to support improved attendance. This can include additional support as laid out in Section 3 of this policy: **Summary of School Action in relation to Attendance.**

10. Authorised Absences- including medical and dental appointments during the school day

Parents are asked to keep to a minimum the occasions when students miss all or part of the school day (e.g. by endeavouring to arrange medical, dental, optician appointments outside school hours or during school holidays).

When medical and dental appointments cannot be arranged for outside school hours, permission for absence should be requested by letter or email in advance via the Attendance email: **Attendance @mgs.kent.sch.uk**. Where permission is granted the student will be required to sign out before leaving the school site at either the Front Reception or The Attendance Office for safeguarding purposes. Students returning school during the day must sign back in.

11. Authorised Absence- One day requests for a Family Event or Off Site Educational Event

Parents should seek permission in advance for a single day leave of absence for a family event such as a wedding, christening or funeral. The school's expectation is that for family events such as these, only a single day of leave will be granted. If, however, additional travelling time is needed then please explain this when completing the leave of absence e-form. Ordinarily, the school will only authorise up to three days including travel to and from the event. To request an extraordinary leave of absence for a family event parents must complete the e-form on the school website at: [Attendance - Maidstone Grammar School](#). This should be submitted two weeks prior to the planned event where possible.

Certain educational off site activities such as university visits, educational interviews, representative sporting fixtures, representative musical performances can help a student to develop their skills and become a well rounded individual. However, it should not be expected that participation will automatically be authorised by the school. The specific nature of the event as well as overall attendance, academic progress and attainment and conduct may all be taken into consideration when deciding whether to authorise absence. Please note that absence requests will only be authorised for driving tests not driving lessons.

To request an extraordinary leave of absence for an educational activity parents must complete the e-form on the school website at [Attendance - Maidstone Grammar School](#). This should be submitted two weeks prior to the planned event where possible.

12. Leave of Absence – exceptional circumstances during term time

From September 2013 the Department for Education has amended the Pupil Registration Regulations, removing the Headteacher's ability to authorise leave of absence for the purpose of a family holiday. Section 444 of the Education Act 1996 says that parents are guilty of an offence of failing to secure regular attendance at school unless they can prove that the child was absent:

- with leave (the school has given permission)
- due to sickness or any unavoidable cause (the sickness or unavoidable cause must relate to the child, not the parent)

- religious observance
- failure by the Local Authority to provide transport

In law these are the only acceptable reasons for a child being absent from school.

All requests for exceptional circumstances will be considered individually, but the default position is that it will not be granted unless there are exceptional compassionate circumstances for example, bereavement or terminal illness within the family.

Generally, the DfE does not consider a need or desire for a holiday or other absence for the purpose of leisure and recreation to be an exceptional circumstance and the default position is that the school will not authorise any holiday in term time.

Holidays which have been accidentally booked during the term time or which have been booked during the term time to take advantage of cheaper booking rates are not considered exceptional circumstances and will not be authorised.

The DfE's G code will be used for family holiday not agreed or days in excess of agreement.

13.Unauthorised Absences

An absence will not be authorised where the school is not satisfied with the reasons given for the absence or where no explanation has been received.

The following reasons are examples of absence that will not be authorised:

- Persistent non-specific illness e.g. poorly/unwell
- Absence of siblings if one child is ill
- Oversleeping
- Inadequate clothing/uniform
- Confusion over school dates
- Medical/dental appointments of more than half a day without very good reasons
- Child's/family birthday
- Shopping trip, theatre trips or "days out"
- Family Holidays (unless the school considers there are exceptional circumstances)

Where there are concerns in relation to attendance, the school will communicate with parents and seek to work with them to address this. See Section 3 above.

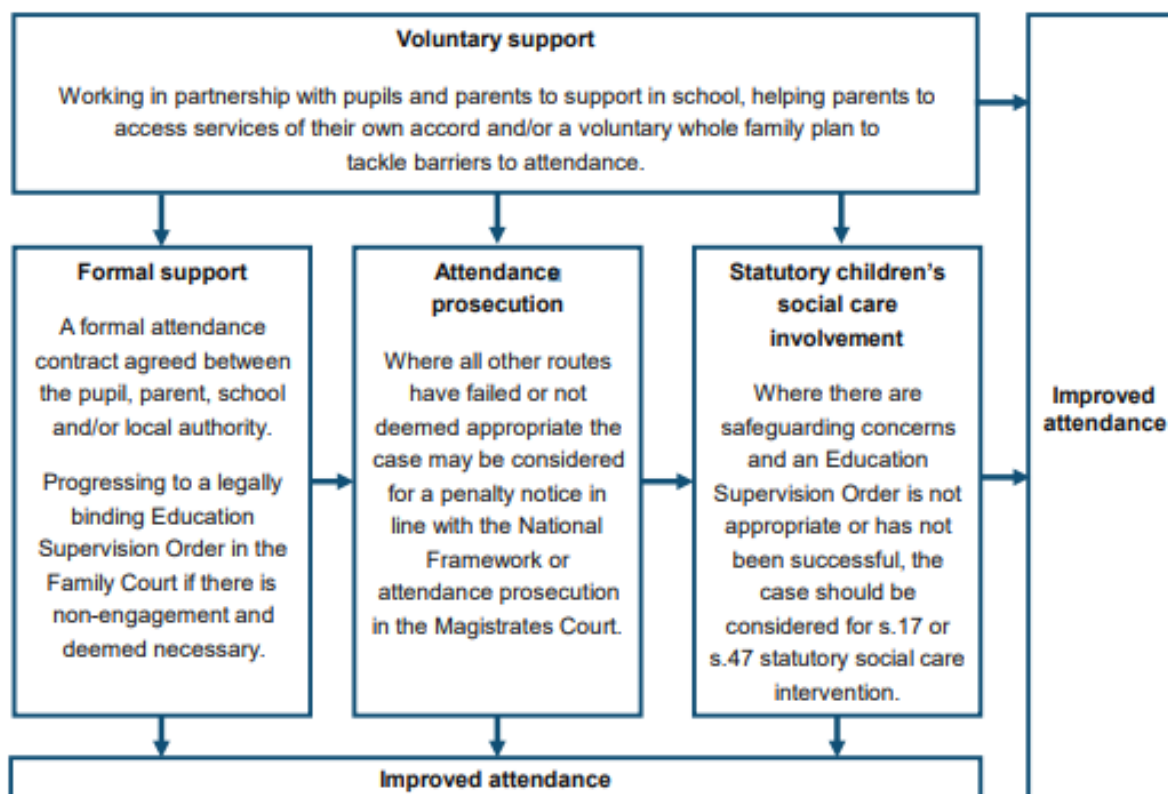
14.Child Missing From Education (CME)

No child may be removed from the school roll without consultation between the Headteacher (or Deputy acting on their behalf) and the PRU, Inclusion and Attendance Service. This applies to children with ten (or more) consecutive days of unauthorised (unknown) absence and:

- Children who are moving abroad / away from the area
- Children who are transferring to a different school (if no official confirmation from the new school is received)
- Children who fail to attend the new academic year/ term (particularly at points of transition)
- Children who suddenly stop attending school
- Children who are removed by their parents for a range of reasons

15. Legal Intervention

The DFE Attendance Guidance 2024 section 135 outlines the Legal Action with regards to school attendance:



Persistent unauthorised absence (attendance below 90%) may result in an AS1 referral to the Local Authority School Liaison Officer for consideration of prosecution. The school will follow procedures prior to referral and parents will be notified in writing. When a referral is made, the child's Registration Certificate, copies of all emails and letters sent to parents and minutes of any meetings will be attached to the completed AS1 referral form with any other relevant information. Local Authority Action may include:

- Attendance Improvement Meeting
- Home visits
- Liaison with other agencies
- Fast Track to Prosecution

At MGS we aim to work with parents to promote / improve attendance. Penalty Notices will be issued on a case by case basis where we consider it appropriate.

A penalty notice is an out of court settlement which is intended to change behaviour without the need for criminal prosecution.

If repeated penalty notices are being issued and they are not working to change behaviour they are unlikely to be most appropriate tool.

Therefore, from autumn term 2024, only 2 penalty notices can be issued to the same parent in respect of the same child within a 3 year rolling period and any second notice within that period is charged at a higher rate:

- The first penalty notice issued to a parent in respect of a particular pupil will be charged at £160 if paid within 28 days. This will be reduced to £80 if paid within 21 days.
- A second penalty notice issued to the same parent in respect of the same pupil is charged at a flat rate of £160 if paid within 28 days.
- A third penalty notice cannot be issued to the same parent in respect of the same child within 3 years of the date of issue of the first.

In a case where the national threshold is met for a third time (or subsequent times) within those 3 years, alternative action should be taken instead. This will often include considering prosecution, but may include other tools such as one of the other attendance legal interventions

Section B: Attendance in the Sixth Form

16. The following section contains further information and detail in relation to Attendance and punctuality in the Sixth Form.

Maidstone Grammar School is committed to the continuous raising of achievement of all students, including in the Sixth Form. Good attendance and punctuality is critical if students are to be successful and benefit from the opportunities presented to them. 95% is the national expected threshold for good attendance. Attendance below 90% is classed as persistent absence and is a significant cause for concern.

We recognise that Sixth Form students are in a transitional stage in their lives, growing in maturity and seeking greater independence. We strive to create a positive learning environment where mutual respect, trust and intellectual curiosity is at the heart of the Sixth Form experience. Students are able to use private study periods to determine their own work priorities and schedules. Facilities such as the extensive War Memorial Library, Sixth Form Private Study Area and Sixth Form Common Room and sporting facilities, including the new gym, are provided with our Sixth Form student population in mind. Students are also permitted to leave site at break

and lunchtime and during free periods from the start of Term 3 (January) in Year 12 so long as no significant attendance / punctuality / academic or behaviour concerns have been identified. In addition, the school provides a wealth of extra curricular and enrichment activities, trips and visits which many Sixth Form students partake in and in which many students also represent the school.

All of these benefits are provided as privileges, not rights. Sixth Form students also have a responsibility to ensure good attendance and punctuality and privileges can be revoked at any time if the school has concerns / considers it appropriate.

17. 6th Form attendance requirements

In line with the Sixth Form Home / School Agreement, signed by students and parents, all Sixth Form students are required to:

- Attend ALL AM/PM Statutory Registrations on time. **This includes ensuring that they are registered at the start of period 1 and 5 on a Tuesday, at the Attendance office if they have a free period.**
- Attend all timetabled lessons on time.
- Attend all timetabled Private Study Sessions on time.

In addition, Sixth Form students are:

- Not permitted to take driving lessons during the school day.
- Strongly advised not to undertake more than 8 hours of paid work per week.
- Not permitted to leave school during a free period 5 unless this has been sanctioned by the Head of Sixth Form and / or the Head of House, following Tracking 1.

18. Recording absence

Unplanned absence:

The legal responsibility for ensuring that children attend school regularly and punctually rests with parents. To this end, all unplanned absences (for reasons such as ill health) must be reported to the School, via email from a parent by 9.00am on each day of absence (attendance@mgs.kent.sch.uk). Alternatively, as a second option, parents can contact the school via the telephone 01622 623922.

Extra-Ordinary Absence:

There may be occasions when sixth form students may request to be off site, for example to attend university interviews, weddings, funerals or for driving tests, etc. In this instance, students and parents must complete the extraordinary absence form found on the website. [Extraordinary Leave of Absence Request Form](#)

19. Unauthorised Absence

Unauthorised absence is any absence that has not been previously reported to and agreed by the school. Absence can only be authorised by the school. Unauthorised absence can include a day's absence, a lesson absence or a form time absence. It can also include a late arrival for a student that arrives after 9am. This receives a 'U' code followed by the number of minutes late (e.g. U30 for a 30 minute late arrival).

In the event that students fail to attend a lesson or form period, the register codes typically use one of the following:

Code	Description	Meaning
N	Reason for absence not yet established	Unauthorised absence
O	Other or unknown circumstances (Not covered by any other code/description)	Unauthorised absence
G	Holiday (NOT granted by the school)	Unauthorised absence

These codes are all visible on Talaxy and available for both Staff and Parents to view.

Procedures where there are concerns around Punctuality / Attendance in the Sixth Form:

Where Sixth Form students are Late to or Absent from am / pm registration without a justified reason agreed by the school they will be issued with a 20 minute LTD for each occurrence.

This is also the case on Tuesdays (when there is no form time session) if:

- a student fails to register/is late period 1 / period 4 in their lesson or
- a student fails to register/is late period 5 in their lesson if they are free period 4 or
- if they are free period 4 /5 they fail to sign in at Attendance at the start of period 4

Where Sixth Form students miss a Private Study period without a justified reason agreed by the school they will be issued with a 40 minute After School Detention.

Where Sixth Form students miss a lesson without a justified reason the minimum of a 40 minute After School Detention will be issued.

Where Sixth Form students miss a day without a justified reason a minimum of an extended 2 hour detention will be issued per missed day.

Where there is lateness to lessons or a private study period students will be issued with a Punctuality Mark on their punctuality / appearance card. Five marks on the card lead to a lunchtime detention.

The onus is on students and parents/carers to ensure that the school has been informed of reasons for lateness or absence. This should be done by 9.00am on the same day as described above.

Sanctions for Sixth Form lateness or absence to statutory am/pm registration and private study periods / lessons will be issued on the following day from break time onwards in Talaxy. This allows a short opportunity where parents can contact the school if they have not already informed the school of a justified reason for lateness / absence on the previous day (please contact via the Attendance email or phone number above). It is the responsibility of the parent to inform the school in such cases.

We recognise that there are times when circumstances require a flexible approach, and we strive to work with parents and students in order to ensure the school's response to any absence is fair and proportionate. At the same time, with 1400+ students at MGS and registers being taken every hour of the school day, the attendance team work with approximately 50,000 records a week. To make this manageable, the following procedures also apply:

- If a student has a valid reason for being absent, but this has not been communicated (e.g. went home unwell but failed to alert a member of staff) the sanction remains in place.
- Should a communication have been made via the channels outlined in this policy (Attendance email or Attendance phone line) and been missed, the record will be reviewed and adjusted as appropriate by the School Attendance Officer.
- Should a communication have been made via a method not shared in this document, (e.g. text messaging, telling other students to tell inform the school, etc...) the record and accompanying sanction will remain in place.

20. In addition the following thresholds and responses apply when reviewing Sixth Form attendance:

Where there are justifiable reasons for lower attendance which are agreed by the school (e.g. a long term medical condition affecting attendance) adjustments may be made to the above arrangements if the school feels it is appropriate.

Selection for extra-curricular teams and attendance on school trips and visits may consider punctuality and attendance, including reasons for absence. Where students have attendance levels below 90% (without good reason as above) or persistent poor punctuality (without good reason agreed by the school) the school may withdraw the privilege of participating in school sport teams, other extra curricular activities and / or trips and visits.

- In cases of significant and ongoing persistent absence or poor punctuality which has not been authorised and agreed by the School, the School reserves the right to withdraw the student's public exam entries and / or remove the student from roll. In addition further sanctions or the withdrawal of permissions / privileges extended to other students can be put in place by the leadership team. The school reserves the right not to permit students with significant attendance / punctuality concerns to participate in MGS extra curricular involvement/ other school activities / trips / visits / any other event or occasion as deemed by the school etc.
- Where a trip / visit has been paid for by parents/ carers and the student's poor attendance and / or punctuality record means that they are no longer permitted to attend the parent will also be responsible for covering the full cost of the activity.

Each case will be dealt with on a case by case basis and the school will act accordingly. The Headteacher's decision is final.
